The scareactors will not touch you, you must not touch them, ever, they will not harm you.

9 Circles is an intense, extreme high level of scare.

This attraction is highly recommended 16+ with parental advisories advised.

The guest will enter the attraction alone with no exceptions. Once the guest has entered the attraction you will not be able to leave until the end of the experience.
